

No. 60-PAR(AR)/P/2R-2/2023

Dated, Kolkata, the 19th January, 2024

In exercise of the power conferred by sub-section (3) of section 7 of the Code of Criminal Procedure, 1973 (2 of 1974) (hereinafter referred to as the said Code) and after consultation with the Hon'ble High Court at Kolkata and in supersession of all previous notifications on the subject, the Governor is pleased hereby –

- (a) to divide with effect from the 19th day of January, 2024, the district of Jalpaiguri into sub-divisions of Jalpaiguri Sadar, **Dhupguri** and Mal; and
- (b) to declare that with effect from the said date, the limits of the three sub-divisions as aforesaid shall comprise the local areas included within the jurisdiction of the police stations as specified by the State Government from time to time in notifications under clause (s) of section 2 of the said Code or clause(s) of sub-section (1) of section 4 of the Code of Criminal Procedure, 1898 (5 of 1898), as shown in the Schedule below:–
