No. 452-PL/PA/IC-05/2023 (Pt-III) dated. 29/02/2024 – In exercise of the power conferred by clause (s) of section 2 of Code of Criminal Procedure, 1973 (2 of 1974) and in modification of all previous Notifications relating to the areas included within the Narendrapur Police Station in the district of South 24 Parganas and the boundaries of that area, the Governor is pleased hereby to declare that with effect from the date of publication of this Notification in the Official Gazette, there shall be a Police Station, namely, Atghara Police Station in the district of South 24 Parganas and the jurisdiction of the said Police Station shall consist of, and include, the areas the details of which are specified in the schedule below:—
