No. 22-Home (Cons)/R2R (Cons)-02/2024 dated 10.01.2025— In exercise of the power conferred by clause (3) of article 166 of the Constitution of India, the Governor is pleased hereby to make, with immediate effect, the following amendments in the West Bengal Rules of Business, as subsequently amended (hereinafter referred to as the said rules):—
