In exercise of the power conferred by section 106, read with sub-section 4 of section 6, of the West Bengal Correctional Services Act, 1992 (West Bengal Act XXXII of 1992), the Governor is pleased hereby to make, with immediate effect, the following amendments in the rules regulating recruitment to the posts of Warder and Female Warder, published with this Department Notification No.784-DCA/4M-02/09/Pt-IV, dated 23rd August, 2013 (hereinafter referred to as the said rules):—

*Amendments*

In the said rules:—

(1) in clause (a) of rule (1), for the words “the West Bengal Staff Selection Commission”, *substitute* the words “the West Bengal Police Recruitment Board”,

(2) for rule (5), *substitute* the following rule:—

“(5) **Physical Efficiency Test**

(a) For Warder (Male): run 1600 Metres (Qualifying time 06 minutes 30 seconds);

(b) For Warder (Female): run 400 metres (Qualifying time 1 minute 50 seconds).

*Note.*— The venue for the Physical Efficiency Test (PET) shall be decided by the West Bengal Police Recruitment Board. The Physical Measurement Test (PMT) and the Physical Efficiency Test (PET) shall be of qualifying nature.”;

(3) For rule (6), *substitute* the following rule:—

“(6). **Written test and interview.** —

- (a) Candidates shall have to appear for a competitive written examination of 90 marks.
- (b) candidates qualified on the basis of written examination, shall be called for Physical Measurement Test (PMT) and Physical Efficiency Test (PET);
- (c) candidates qualified in the Physical Measurement Test (PMT) and Physical Efficiency Test (PET), shall be called for interview of 10 marks;
- (d) the West Bengal Police Recruitment Board shall decide the scheme of the examination and the syllabus and the Board shall conduct the written examination, evaluate and fix qualifying marks for the written examination and prepare merit list on the basis of aggregate of the written test and the interview marks.”.
