MEMORANDUM

In terms of Notification No. 236-AH Dated 24/01/1994, the vacant posts & subsequent vacant posts of West Bengal Junior Animal Husbandry Service (WBJAHS) were required to be included into the erstwhile West Bengal Junior Animal Husbandry & Veterinary Service, which has been elevated to West Bengal Animal Husbandry & Veterinary Service as per Animal Resources Development Department No. 2180-AR & AH/5P-34/95(P-I) Dated 17/10/2000. However, no such process have been initiated till date.

Keeping in view the fact that the present strength of West Bengal Junior Animal Husbandry Service (WBJAHS) Cadre is very low as the vacant posts are not being filled up through direct recruitment as a Govt. Policy since long and also keeping in view that due to adoption of advanced Scientific Technology in the working sphere of Animal Resources Development Department, functionality of such cadre of West Bengal Junior Animal Husbandry Service (WBJAHS) has become minimalistic, the undersigned is directed by order of the Governor to say that the Governor has been pleased to declare the cadre 'West Bengal Junior Animal Husbandry Service' (WBJAHS) as dying cadre with immediate effect subject to the following terms and conditions:

- (i) Out of Cadre strength 317, existing 272 (two hundred seventy-two) vacant posts of the West Bengal Junior Animal Husbandry Service (WBJAHS) will be absorbed into the integrated service 'West Bengal Animal Husbandry & Veterinary Service'.
- (ii) Subsequently vacant posts of WBJAHS arising out of promotion or retirement or otherwise shall not be filled up.
- (iii) Existing promotional prospects of the members of West Bengal Junior Animal Husbandry Service (WBJAHS) shall remain unaltered.
- (iv) The West Bengal Junior Animal Husbandry Service (WBJAHS) shall have no existence once all the existing incumbents of the said service vacate their existing posts by promotion, retirement or otherwise.

This is issued with the concurrence of the Finance Department vide U.O. No. Group P1/2025-2026/0045 UO Date 21.04.2025. & approval of the Cabinet vide No. 1289 Dated, Kolkata, June 17, 2025.


