SHEWETH:

1. The Krishi Bikash Shilpa Kendra i.e. KBSK the organization, petitioner No.2 has been established and registered on 27.09.1979 under the land Reforms Department Vide Record No. 95558, L.R. Birbhum dated 03.09.1979 having its Registered Office giving in the cause title hereof for implementation of 20 points programme of the Govt. of India.

A copy of the said registration dated 27.09.1979 is annexed herewith and marked as Annexure "P-1".

2. The petitioner no.1 is the Secretary elected by the Board of Members of the Organisation having the locustandi to represent the organization i.e. petitioner no.2, as and when required and has been required to do so by the resolution of the Board of Members of the Organisation.

Your petitioners crave leave to produce all the relevant papers and documents in support of the above statements at the time of hearing, if necessary.

- 3. The main object of the petitioner no.2 was to implement the 20 points programme of the Government of India in close collaboration with the Department of Agriculture and Rural Development for upliftment of the weaker section of the society and down trodden people of the rural sector of Bengal and it is carried out by the petitioners till date through the organization KBSK.
- 4. Time to time petitioner no.2 was appreciated and recommended by the office of the Prime Minister as well as the Govt. of India as a good organization and empowered to implement the 20 points programme in the State of West Bengal.

In support of the above statement letters dated 09.02.1982 and 16.04.1982 are annexed herewith and marked with letter "P-2" collectively.

5. On or about 06.05.1982 petitioner no. 2 Informed Prime Minister's Office when it was facing financial troubles for maintaining the office and day to day expenditure and honorarium to its workers for regularization of its workers. In reply to that vide its letter dated 22nd July 1982 the office of the Prime Minister intimated the petitioners to the effect that its workers would be absorbed afterwards.

Copy of the letters dated 06.05.1982 and 22.07.1982 and 17.11.1982 are annexed herewith and marked with letter "P-3".

branches and firms for spreading improved techniques of crop, animal husbandry; family planning and family welfare and time to time intimated, the Prime Ministers Office about its functioning and activities for implementation of 20 point programme as formulated by the Government of India. The Prime Minister's office having forwarded the said letter of the petitioners to the Chief Secretary to the Government of West Bengal for appraisal and by taking appropriate action in the affairs and to render all possible assistance by the State Government in favour of petitioners.

Vide its letter dated 12.04.1982 the Government of West Bengal Agriculture Department deeply appreciated the interest and activities of petitioner no.2 and endorsed the copy of the said letter to the District Magistrate of Birbhum with a request to ensure to provide petitioner no.2 all sorts of assistance from the District Office to run the programme smoothly and fulfill the preconditions as prescribed as assistance.

7. Your petitioner no.2 used to keep close contact by informing the Prime Ministers office as well as to the Department of Agriculture Government of West Bengal about its progress of work for taking over and absorption of its workers. In response to that it was appreciated highly and intimated about consideration for taking over the firm in future by the Government.

In support of the above statements copies of the letter dated 08.03.1985, 18.04.1985 are annexed herewith and marked with the letter "P-4" collectively.

8. The Secretary to the Govt. of West Bengal Dr. P.V. Shenoi Vide its letter dated 23rd May 1985 forwarded an exhaustive report in the matter pointing out therein that the organization is running over 70 branch offices with more than 4200 workers who are performing this duties through petitioner no.2 and regretted that the Government of West Bengal could not take over the firm and expressed its regret that such workers ought to be regularized on sympathetic ground vide Memo no. F-2-57(4)82PMPI dated 22.07.82 as they were assured to be regularized as per empowerment of Prime Minister's office vide no. F-2-38(4)/82PHPI dated 16.04.1982.

In support of the above statement copy of letter dated 23.05.1985 is annexed herewith and marked with the letter "P-5".

9. By virtue of 73 rd Constitutional Amendment Act 1993 the office of the Prime Minister vide his letter dated 1st March 2011 has been pleased to say that as the matter relates to 20 points programme which is now vested with the State Government, as such to pursue the matter with the Department

Accordingly, the representation of the petitioner no. 2 was forwarded to the Chief Secretary Government of West Bengal for taking necessary action.

Copy of the said letter dated 01.03.2011, 02.05.2011 are annexed herewith and marked with the letter "P-6".

It is pertinent to mention that the Ministry of Statistics and programme implementation (MOSPI) was set up on 15.10.1999 to monitor the 20 point programme in India.

10. The Assistant Secretary to the Govt. of West Bengal directed the Joint Secretary, Agriculture Department, Government of West Bengal to take immediate redressive action within 15 days from receipt of the communication dated 14.06.2011 and send the action taken report to the petitioner with an intimation to his department.

Copy of the said letter dated 14.06.2011 is annexed herewith and marked with "P-7".

11. The Government of India Ministry of Law and Justice vide its letter dated 17th June 2011 informed the petitioner no.1 that the subject matter now totally under the domain of the Department of Agriculture, Government of West Bengal for implementation of 20 points programme as such West Bengal Government is the appropriate authority to take appropriate steps in this regard.

Copy of the said letter dated 17.06.2011 is annexed herewith and marked as annexure "P-8".

12. Your petitioner no.1 left no stone unturned for getting an order for regularization of the workers. By letter dated 06.09.2011 the Assistant Secretary and SPIO of Chief Ministers office took initiatives and directed the Secretary Agricultural Department Government of West Bengal Writers Building Kolkata to wards implementation of the direction of the Hon'ble High Court dated 13.10.2009 within a period of 15 days and informing the action taken report to the incumbent.

A copy of the said letter dated 06.09.2011 is annexed herewith and marked as annexure "P-9".

- 13. Lastly the Department of Agriculture Government of West Bengal informed although the Government is very much desirous to do something in this matter but as there is no specific direction by the Hon'ble Court to the Department as such the Government is not under any obligation to implement the same and regretted.
- 14. Inspite of repeated request and recommendations made by the Government of India Planning Commission, Section Officer of prime Minister's Office, Assistant Secretary to the Government of West Bengal, Governor's Secretariate Ministry of Statistic and Programme implementation (TTP) Division etc. the respondent authorities were very negligent to regularize the petitioner's organization for achieving the assured goal of the petitioners.
- 15. Your petitioners submit that the 4200 strong members as assured by the Government who are rendering voluntary services day and night for the development and improvement of Society i.e. petitioner no.2 with the hope

that they will be given the status of State Government undertaking, are violative of Article 23 and 21 of the Constitution of India.

- 16. Your petitioners submit that the petitioners are being deprived of the benefit of National Rural Employment Guarantee Act 2005 which provides 100 days of employment to one member of each house hold in the rural areas as they work day and night throughout the year among the backward section of society, implementing 20 points programme of the respondents without any remuneration and/or benefit.
- 17. Your petitioner lastly filed a writ petition being no. 4936 (W) of 2012 before Hon'ble High Court at Calcutta for redressal to the effect that the respondent authorities to forth with take necessary steps for taking over petitioners in terms of the report and recommendation of the Secretary to the Government of West Bengal Agriculture Department dated 23rd May, 1985. Your petitioner crave leave to refer the Writ Petition at the time of hearing if necessary. Then same was came up for hearing finally on 31.08.15. The Hon'ble Justice Arijit Banerjee and His Lordship was pleased to dispose of the same with a specific direction upon the Respondent no.2 i.e. the Department of Agriculture Government of West Bengal inter alia to consider petitioners representation dated 15.07.2011 in accordance with law by a reasoned order after giving an opportunity of hearing to the petitioner within a period of

two months from the date of communication of this order with a liberty to the petitioner to produce all the relevant documents and the authority should consider the same. The order passed by the respondent should be communicated to the petitioner within ten days from the date of the order.

A copy of the said order dated 31.08.2015 is annexed herewith and marked as annexure "P-10".

18. In compliance with the said order the Additional Secretary Agricultural Department, Government of West Bengal upon hearing the parties passed a purported reasoned order being no. 256/L-67/II P=(1) dated 09.11.2015 and communicated the same to the all concern.

A copy of the said reason order dated 09.11.2015 is annexed herewith marked with the letter "P-11".

19. Your petitioners submit that the above purported reasoned order has been passed totally by non application of mind and without going through the relevant document specially the representation of the petitioners dated 15.07.2011 and letters of appreciation, recommendations time to time given by the high Government officials even from the Department itself in favour of the organization..

- 20. Your petitioners submit that while passing the purported reasoned order the Additional Secretary, Agricultural Department had a very limited scope to consider only the representation dated 15.07.2011 by the petitioners and to dispose it off but not beyond that. In the instant case it was considered otherwise which is not tenable in law.
- 21. Your petitioners submit that the respondent authorities failed to appreciate that the report and recommendation of the Secretary of the Govt. of West Bengal Agriculture Department dated 23.05.1985 was very specific with the observation that the works of organization KBSK have been worked as per empowerment of the Hon'ble Prime Minister's office (vide no. F-2-38(4)/82 PMPI dated 16.04.82 and they were assured that their workers would be regularized after words (vide no. F-2-57(4).82 PHPI dated 22.07.1982. Further more, it is proposed before the Govt. of West Bengal to take over the aforesaid 4200 Nos of workers of the organization at least on the sympathetical ground.

Therefore, by denying the petitioner's grievance in the proper perspective, the Additional Secretary has shown unreasonable attitude and that too in a cavalier manner.

- 22. Your petitioners submit that it is not correct to say that the organization is functioning without any authorization as such Government has no responsibility towards the employees of KBSK on the contrary it is right to say that since from the beginning i.e. from 1979 on the basis of recommendations and with the assurance and assistance of Government the petitioners' organization had been running the KBSK till date. Time to time the work of this organization was not only empowered but the execution of such trust was duly appreciated, encouraged and well recognized by the Government of India as well as by the State Government.
- 23. Your petitioners submit that denying the right of 4200 strong member of the organization who have been rendering their services day and night for the rural development and for the benefit of weaker section of the society is grossly violative of Article 23 of the Constitution of India and that too in a sphere of implementation of the Government Policy.
- 24. Your petitioners submit that the petitioners are also being deprived of the benefit of National Rural Employment Act 2005 which provides 100 days of employment to one member of each household in rural areas, as they work day and night throughout the year generation after generation among the

backward section of the society, for implementation of 20 points programme without any remuneration and benefit.

- 25. Your petitioners submit that Article 38, 41, 43, 46 and 48 of the Constitution of India seeking to establish a welfare state with social economic and political justice for all. But this dream will become shuttered if the people living below poverty line including schedule caste, schedule tribe and other backward class are not brought into the social main stream through development. The petitioners are tirelessly toiling to achieve these object which in practice ought to be done by the respondents and the petitioners will not reach that goal until and unless they are not brought under the Ministry of Agriculture and Rural Development of Government of Agriculture and Rural Development of West Bengal as per candid and clear assurance by the Government of India.
 - 26. Your petitioners submit that they left no stone unturned to achieve their legitimate claim but due to non co-operation on the part of the respondents, despite receiving several representations and given assurances, authority turned down your petitioner's claim of taking over and regularization of workers namely Krishi Bikash Shilpa Kendra under the

Ministry of Agriculture and Rural Development of Government of West Bengal only with bias and ire.

- 27. Your petitioners submit that the claim of the petitioners are sound neutral and well defined by Government assurance of the technical and personal skills to implement Government Scheme which is binding nature already possessed by the workers of Krishi Bikash Shilpa Kendra have been well tested and appreciated.
- 28. Your petitioners submit that by refusing or rejecting your petitioners' claim by its order dated 09.11.2015 the respondent authority i.e. Ministry of Agriculture and Rural Development of Government of West Bengal is acted illegally, whimsically, capriciously and against the provisions of law of the land and as well as contrary to the principals of natural justice and fair play and also contrary to the principles of promissory estoppel from departing from their promises to absorb your petitioners on the following amongst others—

GROUNDS

 For that the above purported reasoned order has been passed totally by non application of mind and without going through the relevant document specially the representation of the petitioners dated 15.07.2011 and letters of appreciation, recommendations time to time given by the high officials in favour of the organization and assurance by virtue of which 4200 workers of KBSK are rendering this services voluntarily so long with the hope that they will be absorbed by the State Government.

- II. For that while passing the purported reasoned order the Additional Secretary Agricultural Department had a very limited scope to consider only the representation dated 15.07.2011 by the petitioners and to dispose it off but it was considered otherwise which is not tenable in law.
- III. For that the respondent authorities failed to appreciate that the report and recommendation of the Secretary of the Govt. of West Bengal Agriculture Department dated 23.05.1985 was very specific with the observation that the works of organization KBSK have been worked as per empowerment of the Hon'ble Prime Minister's office (vide no. F-2-38(4)/82 PMPI dated 16.04.82 and they were assured that their workers would be regularized after wards (vide no. F-2-57(4).82 PHPI dated 22.07.1982. Further more, it is proposed before the Govt. of West Bengal

to take over the aforesaid 4200 Nos of workers of the organization at least on the sympathetical ground. Therefore by denying the petitioner's grievance in the proper perspective the Additional Secretary has shown and that to cavalier.

- IV. For that it is not correct to say that the organization is functioning without any authorization as such Government has no responsibility towards the employees of KBSK on the contrary it is right to say that since from the beginning i.e. from 1979 only on the basis of recommendations and with the assurance and assistance of Government the petitioners' organization had been running the KBSK till date. Time to time the work of this organization was not only empowered but the execution of such trust was duly recognized, appreciated and encouraged by the Government of India as well as by the State Government.
 - V. For that by denying the right of 2450 strong member of the organization who have been rendering their services are working day and night voluntarily for the rural development and for the benefit of weaker section of the society is grossly violative of Article 23 of the Constitution of India and that too in a sphere of implementation of the Government Policy.

- VI. For that the petitioners are also being deprived of the benefit of National Rural Employment Act 2005 which provides 100 days of employment to one member of each household in rural areas, as they work day and night throughout the year among the backward section of the society, for implementation of 20 points programme without any remuneration and benefit.
- VII. For that Article 38, 41, 43, 46 and 48 of the Constitution of India seeking to establish a welfare state with social economic and political justice for all. But this dream will become shuttered if the people living below poverty line including schedule caste, schedule tribe and other backward class are not brought into the social main stream through development. The petitioners are tirelessly toiling to achieve these object which in practice ought to be done by the respondents and the petitioners will not reach that goal until and unless they are not brought under the Ministry of Agriculture and Rural Development of Government of Government of Agriculture and Rural Development of West Bengal as per candid and clear assurance by the Government of India.

- VIII. For that they left no stone unturned to achieve their legitimate claim but due to non co-operation on the part of the respondents despite receiving several representations and given assurances turned down your petitioner's claim of taking over and regularization of workers namely Krishi Bikash Shilpa Kendra under the Ministry of Agriculture and Rural Development of Government of West Bengal only with bias and ire.
 - IX. For that the claim of the petitioners are sound, rational and well defined by Government assurance of the technical and personal skills to implement Government Scheme which binding nature already possessed by the workers of Krishi Bikash Shilpa Kendra have been well tested.
 - X. For that by refusing or rejecting your petitioner claim by the purported order dated 09.11.2015 the respondent authority has acted illegally whimsically, capriciously and against the provisions of law of the land as well as contrary to the principals of natural justice and fair play and also contrary to the principles of promissory estoppel from depating from their promises to absorb your petitioners.

- 30. There is no other efficacious alternative legal remedy than to move this application before this Hon'ble Court under its constitutional writ jurisdiction and the relief sought for herein if granted will afford justice to the petitioner.
- 31. Your petitioners state that in the facts and the circumstances of the case the justice was demanded but the same has been refused.
- 32. On the self same cause of action and relief no application has been moved before this Hon'ble Court or any other forum save and expect as disclosed above.
- 33. The records of the case are lying with the respondent authorities within the appellate side jurisdiction of this Hon'ble Court.
- 34. The balance of convenience and inconvenient of the case is in favour of the petitioners for passing the order as prayed herein.
- 35. The application is made bonafide and for the ends of justice.

In the facts and circumstances as disclosed hereinabove your petitioners

most humbly pray that Your Lordships may graciously be pleased to issue :

As per the reports from the District Magistrates, it is disillusioned that the workers of KBSK are cultivating Rice, Wheat, Potatoes, Mustered Seed, Jute etc. by taking lands in contracts basis from the land owners in the ratio – 50% KBSK and 50% Owners of Land.

In some places they engaged in psicultures, some places Mango cultivation, some places in sericulture, horticulture, poultry, hand loom etc.

In this way they make some profits and by collecting money from the local doners they give some honorarium to their workers, organize small agricultural fair exhibition, seminer, workshop etc., some times give tailoring machine and stretchers to the needful, supplying smokeless chullah to save fuel etc., they sink tube-well in some places for fresh drinking water and low cost latrine in backward area, they making school-addicted to the children, supplying books, slate etc. to the children of poor family, supplying iron tablets and Neutrious food to the pregnant women of the weaker sections, some time motivate the farmers to use the seeds of higher yielding variety and harvesting scientifically etc., producing Molasses etc. Plantation in vacate lands, Banks of tanks and canals, sides of roads etc. to balance the environment and Eco-System, they organize Blood Donation Camps.



WHEREAS, Krishi Bikash Silpa Kendra describes itself as the only organisation in West Bengal that started implementing Government of India's 20 point programme for agricultural and rural development. Their main demand is absorption of their more than 4200 workers by the government.

AND WHEREAS, a writ petition being W.P. No. 4936(W) of 2012 was filed in the High Court and moreover CAN 4111 of 2012 and also CAN 9263 of 2012 were made in connection with W.P. No. 4936(W) of 2012.

AND WHEREAS, in the writ petition it is stated that the case being W.P. No. 4936(W) of 2012 in the matter of Sri Amar Dam & Anr. –VS-- State of West Bengal & Ors. has been filed against no-action on the part of the respondents for absorption of more than 4200 workers of KBSK in pursuance of the 20 points programme stand for the State Government.

AND WHEREAS, it is seen from the writ petitioner that the petition has represented before the Hon'ble Court to direct and/or order the respondents authorities for (i) granting financial assistance for implementation TTP in West Bengai (ii) absorption of more than 4200 workers of KBSK.

AND WHEREAS, in the order passed by the Hon'ble High Court dated.31.08. 2015 in W.P. No. 4936(W) of 2012 in the matter of Sri Amar Dam & Anr. –VS-- State of West Bengal & Ors., it is directed to consider the report and recommendation of the Secretary to the Govt. of West Bengal, Agriculture Department, dated 23.05.1985 and the representations of the petitioners, dated 24.01.2011 and 15.07.2011 in accordance with law by a reasoned order after giving an opportuinty of hearing to the petitioner within a period of two months from the date of communication of this order.

AND WHEREAS, in compliance with the said order dated.31.08.2015, Sri Amar Dam, Secretary of KBSK was requested to attend personally (or with his authorised representative, if desired) before the undersigned for hearing on 05.10.2015 vide this Deptt. Memo No.222/AG/O/L-67/11(Pt-I) dated. 24.09.2015.

AND WHEREAS, according to Order of the Hon'ble High Court dated. 31.08. 2015, the incumbent was not present on 05.10.2015 in the said hearing but his representative took part in the hearing(Attendance sheet enclosed).

AND WHEREAS, W.P. 17838(W) of 2004 and W.P(Civil) No.150 of 2009, were disposed off, by Hon'ble High Court at Calcutta and Supreme Court of India.

AND WHEREAS, it also appears from the order of the Govt. of India that Agriculture Department, Govt. of W.B. had passed a reasoned order vide No. 109/L-49/2004 dated 29.04.2005 stating that this Department has no role to play in the matter. This was quoted in the true copy of the order no. 2-46/2009-policy dated 19.05.2010 of the Govt. of India, Ministry of Agriculture, Department of Agriculture and Co-operation, Krishi Bhavan, New Delhi-11001

AND WHEREAS, Govt. of India issued an order vide No. 2-46/2009-policy dated 19.05.2010 dismissing all pleas and stated that such frivolous and vexatious litigation has led to wastage of considerable time, energy and resources of Government and went on further saying "the farcical nature of this organization is widely publicized so that simple persons are not taken into a ride under the belief that KBSK is a Government organization".

AND WHEREAS, with reference to this Department's letter no. 222/AG/O/L-67/11(Pt-I) dated. 24.09.2015, Sushila Ananth, Deputy Secretary to the Govt. of India, Department of Agriculture Cooperation and Farmers Welfare, informed vide his letter dated D7.1D. 2015 that the Ministry of Statistics and Programme Implementation which monitors Twenty Point Programme has clarified vide D.O. No. 1/8/2012-TPP dated 12.D9.2012 that KBSK has not been authorized at any stage to implement the Twenty Point Programme or any part of it and appears to be no involvement of this Department in the said case.

Now, after hearing and careful consideration of the facts of present case, it is observed that since the organisation is functioning without any Government authorization and the Government has no responsibility towards so called employees of KBSK/KVSK, hence their petition is hereby rejected. It is further observed that this case has resulted in loss of precious time of the Hon'ble Court(s) and also officials of the concerned departments. Hence litigations of this nature should be discouraged.

All concerned may be informed accordingly for further course of action.
