


## POINTS OF LAW


- I. Whether the acts and activities of the Respondent Authorities in depriving the Petitioner Promotion to the Post of Lower Division Clerk by refusing to implement the Recommendations of Shetty Commission with retrospective effect on and from 01.04.2003 in the facts and circumstances of the case are all illegal, malafide, opposed to all norms of Procedural and other Natural Justices as also without any Jurisdiction;
  - II. Whether in a clear instance of administrative anarchism a Government machinery has openly refused to implement and/or disobeyed the Government Order relating to implementation of the Recommendations of Shetty Commission to which this Hon'ble Court may be pleased to take appropriate Judicial Notice;
  - III. Whether the Judgeship in Bankura in under a liability / obligation to implement the Government Notification being 5140J dated 20.07.2009 for implementation of the Recommendations of Shetty Commission.
  - IV. Whether Seal Bailiffs are not entitled to Promotion in the Post of Group-D as per the Recommendation of the Shetty Commission since they are not at par with the Process Servers in terms of Government Notification being 5140J dated 20.07.2009 and on that ground alone the

impugned Order No. 230 dated 11.08.2015 and Order No. 29 dated 02.02.2012 is liable to be set aside by this Hon'ble Court;

V. Whether the concerned Authorities are under the obligation / liability to fill up the Promotional Posts in the L.D.C. Cadre i.e. 25% of all the vacant L.D.C. ## MOST RESPERCTFULLY SHEWETH:

- That Your Petitioner is a law abiding Citizen of India and is residing at the address appended in the cause title of the instant Writ Petition.
- That the Respondent Authorities are State and/or Statutory Bodies as enumerated in List-II(65) under the VIIth Schedule of the Constitution of India discharging powers and responsibilities of State within the meaning of Article 12 of the Constitution of India and as such they are amenable to the Writ Jurisdiction of this Hon'ble Court under Article 226 of the Constitution of India.
  - That the Petitioner states that on 01.11.2006 the Petitioner joined in the 3. Judgeship of Bankura under Jurisdiction of Respondent No.4 as a Non-Judicial Group-D Staff and presently holding the post of an Ejlash Peon i.e. a qualified Group-D Post in the Court of Civil Judge (Junior Division), Bishnupur within the establishment of Learned District Judge, Bankura.

4. That the Petitioner states that the Respondent No.5 who has joined in the Judgeship of Bankura on 19.07.1978 and was holding the Post of Seal Bailiff within the process Establishment in the District's Judges Court, Bankura as on 01.01.2015 is being Promoted in the Post of Lower Division Clerk i.e. a Group-C post w.e.f. 19.08.2015 vide impugned Order dated 11.08.2015 issued by the Office of Respondent No.4.

It is further stated that the Proforma Respondent who has joined in the Judgeship of Bankura on 11.04.1997 and was holding the Group-D Post of an Office Peon in the Court of the Learned Additional District Judge, Bishnupur as on 01.01.2015 is being Promoted in the Post of Lower Division Clerk i.e. a Group-C post w.e.f. 19.08.2015 vide impugned Order dated 11.08.2015 issued by the Office of Respondent No.4.

The Petitioner craves leave of this Hon'ble Court to refer the Gradation List in respect of Process Servers and Group-D employees in the Judgeship of Bankura as on 01.01.2015 at the time of hearing of the instant Writ Petition.

5. That the Petitioner states that in terms of Article 141 of the Constitution of India, the Hon'ble Supreme Court in it's Solemn Order dated 07.10.2010 Passed in Writ Petition (Civil) No. 1022/1989 (All India Judges Association -Vs.- Union of India) Directed the States to implement the Recommendations of 1st National

Judicial Pay Commission i.e. Shetty Commission which framed the Pay Structures and Service Conditions of Subordinate Court Employees. It is a Clear guide line regarding payment of allowances and improvement of service conditions of the Non-Judicial Staffs likewise the Petitioner and Private Respondents in District and Subordinate Courts in the State. There is a mandate under the said guideline that financial implication shall be implemented with retrospective effect i.e. on and from 01.04.2003.

6. That the Petitioner states that the Judicial Department, Government of West Bengal vide Memo No. 5140J dated 20.07.2009 set forth the modes for implementation of the recommendations of the Shetty Commission for the Staffs attached to the Process Serving establishment in the Sub-Ordinates Courts in the State along with Regular Recruitment Rules, Promotion Policies and Qualifications etc. w.e.f. 01.04.2003. The same is issued with concurrence of Finance (A) Department vide U.O. No. 1561-Gr 'P' (Service) dated 01.06.2009.

A careful scrutiny of the Memo dated 20.07.2009 shall further reveal that the same mandates Reservation in Group-C posts i.e. in the clerical cadre at the Entry Level with an emphasis that 'Process Servers with requisite qualification shall be considered for Promotion with other categories of Group-D Employees

to the extent of 25% in L.D.C. Cadre in the ratio of 1:2 (Process Server-1 and other Group-D Employees-2).

7. That the Petitioner states that the Petitioner on 06.08.2015 has submitted an application before the Learned District Judge, Bankura with a prayer for implementation of the Recommendations of Shetty Commission admissible in terms of Memo dated 20.07.2009 as referred hereinbefore so as to submit His candidature for Promotion in the Post of Lower Division Clerk from Group-D Cadre. The Application of the Petitioner has been forwarded through proper channel vide Memo No. 242 dated 06.08.2015 by the Office of the Learned Civil Judge (Junior Division), Bishnupur.

A copy of the Memo dated 06.08.2015 as aforesaid is annexed hereto and marked as Annexure - P/2 to the instant Writ Petition.

8. That the Petitioner states that in the mean time Petitioner preferred one Application under Right to Information Act, 2005 and the information furnished to the Petitioner vide Memo No. 710 dated 17.09.2015 does reveal that the Judgeship in Bankura has 'not implemented' the Recommendations of Shetty Commission regarding promotion of Process Servers and other Group-D

Employees in the Post of Lower Division Clerk at the ratio of 1:2 to the extent of 25% in the L.D.C. Cadre.

A copy of the Memo dated 17.09.2015 as aforesaid is annexed hereto and marked as Annexure – P/3 to the instant Writ Petition.

Commission for the Staffs attached to the Process Serving establishment regarding promotion policies.

A copy of the Memo dated 26.11.2015 as aforesaid is annexed hereto and marked as Annexure - P/5 to the instant Writ Petition.

11. That the Petitioner states that even after due intervention by the Office of Respondent No.1, the Petitioner made Applications one after another on 18.12.2015 and again on 05.02.2016 praying implementation of the Recommendation of the Shetty Commission with regard to the Promotion of Process Servers and Group-D Employees in the L.D.C. Cadre. The Applications as aforesaid have been forwarded through proper channel before the concerned Respondent vide Memo No. 316 dated 18.12.2015 and memo No. 30 dated 05.02.2016.

Copies of the Memo dated 18.12.2015 and 05.02.2016 are annexed hereto and collectively marked as Annexure - P/6 to the instant Writ Petition.

12. That the Petitioner states that in the mean time in purport compliance of the Memo dated 20.07.2009 being Annexure - P/1 to the instant Writ Petition and in consideration of an alleged Report by the Review Committee, the Office of the Respondent No.4 issued Order No. 29 dated 02.02.2012 whereby and whereunder save and except the three (3) Seal Bailiffs, other process Servers

within the Judgeship of Bankura have been adjudged to be beyond the purview of the Notification dated 20.07.2009 for implementation of the Recommendations made by the Shetty Commission.

A copy of the Order dated 02.02.2012 as aforesaid is annexed hereto and marked as Annexure - P/7 to the instant Writ Petition.

13. That the Petitioner states that for filling up 25% of the ten (10) vacancies in the category of Lower Division Clerk within the Judgeship of Bankura, the Office of the Respondent No.4 vide Order No. 230 dated 11.08.2015, Promoted Respondent No.5 in the Post of L.D.C. Clerk w.e.f. 19.08.2015 from the post of Seal Bailiff in purported compliance of the Recommendations made by Shetty Commission as mandated vide Government Notification dated 20.07.2009 being Annexure – P/1 to the instant Writ Petition.

A copy of the Order dated 11.08.2015 as aforesaid is annexed hereto and marked as Annexure - P/8 to the instant Writ Petition.

14. That the Petitioner submits that the Learned District Judge, Bankura being Respondent No.4 to the instant Writ Petition has misconstrued the Government Notification dated 20.07.2009 being Annexure – P/1 to the instant Writ Petition and passed the Orders impugned being Annexure – P/7 and Annexure – P/8 to the instant Writ Petition. The Government issued the Notification dated

20.07.2009 to extend the benefit of Shetty Commission's Recommendations only to the Process Servers / Summon Bailiffs having qualification of class VIII standard i.e. to promote those Process Servers in the post of Lower Division Clerk to the extent of 25% in L.D.C. Cadre in the ratio of 1:2 along with other Group-D Employees. The Process Establishment in Mofussil Courts have been restructured constituting two cadres i.e. Process Servers / Summon Bailiffs and bailiffs / Seal bailiffs. The existing Cadre of Process server as on 20.07.2009 has been re-designated as Seal bailiffs having qualification of School Final or equivalent examination and those have been recommended to enjoy higher pay scale of Rs. 3350-6325/- in comparison to the Process Servers who are assigned Lower pay Scale of Rs. 3150-5680/-. It is further notified that the Promotional Policy of Bailiffs / Seal bailiffs may be determined by the Hon'ble High Court, Calcutta. However it is made clear in the Notification dated 20.07.2009 that bailiffs / Seal bailiffs who are enjoying higher scale of pay are not entitled to be put in the same league with the Process Servers and cannot be considered for Promotion in the Post of a Lower Division Clerk along with other Group-D Employees to the extent of 25% of the L.D.C. Cadre and @ 1:2 (Process Server-I, Group-D Employee-2). Hence the impugned Order dated 11.08.2015 being Annexure - P/8 to the instant Writ Petition is liable to be set aside to the extent of Promotion of Respondent No.5 who was holding post of Seal Bailiff at the time of such Promotion and the impugned Order dated 02.02.2012 is liable to be set aside to extent of the finding that other Process Servers of this Judgeship do not come under the purview of the said Notification for implementation of the recommendation of the Shetty Commission.

15. That the Petitioner further submits that till the day of affirmation of the instant Writ Petition at least thirty (30) vacancy exist in the Judgeship of Bankura in the Cadre of Lower Division Clerk. But the Authorities are seemingly reluctant to fill up such post as per the Recommendations of Shetty Commission and Notification dated 20.07.2009 which appears to be an open refusal to obey the Government Police by the Respondent No.4 being a Government machinery itself and the same is an unique instance of Administrative anarchism to which this Hon'ble Court may kindly be pleased to take appropriate Judicial Notice.

The concerned Authorities must fill up all the posts vacant in Group-C cadre or at least for the time being fill up 25% of such post at the ratio of 1:2 i.e. from Process Server-1 (one) and from Group-D 2(two) with retrospective effect on and from 01.04.2003 which entitles the Petitioner to come under the Zone of consideration for such Promotion in Group-C posts.

- 16. That the Records of the Case are lying outside the Original Side Jurisdiction of this Hon'ble Court.
- 17. That there is no adequate, alternative legal remedy and the remedy sought for if granted will be full, efficacious and complete.
- 18. That on the self same cause of action and the matters in dispute no other Proceeding is pending before any Court of Law.
- 19. That in the facts and circumstances of the Case no useful purpose will be served in demanding Justice so as to observe an empty formality.
- 20. That the Petitioner shall suffer irreparable loss and hardship unless the Respondents, their men, agents and subordinates are restrained by an Order of Injunction from giving any effect and/or further effect and/or from acting in any manner whatsoever on the basis of the impugned Orders dated 11.08.2015 and 02.02.2012 being Annexures P/8 and P/7 respectively to the instant Writ Petition pending disposal of the same.
  - 21. That being aggrieved by and/or dissatisfied with the acts and activities of the Respondent Authorities in Refusing to implement the Recommendations of 1st National Judicial Pay Commission i.e. Shetty Commission thereby depriving the Petitioner promotion to the Post of Lower Division Clerk, Your Petitioner begs to move Your Lordships on the following amongst other:

#### GROUNDS

- I. For that the acts and activities of the Respondent Authorities in depriving the Petitioner Promotion to the Post of Lower Division Clerk by refusing to implement the Recommendations of Shetty Commission with retrospective effect on and from 01.04.2003 in the facts and circumstances of the case are all illegal, malafide, opposed to all norms of Procedural and other Natural Justices as also without any Jurisdiction.
  - II. For that the Authorities discharging Statutory functions must to act fairly but in the instant case they have acted in a most unfair manner in refusing to implement the Recommendation of Shetty Commission which is law in terms of Article 141 of the Constitution of India.
  - III. For that in a clear instance of administrative anarchism a Government machinery has openly refused to implement and/or disobeyed the Government Order relating to implementation of the Recommendations of Shetty Commission to which this Hon'ble Court may be pleased to take appropriate Judicial Notice.

- IV. For that the Judgeship in Bankura in under a liability / obligation to implement the Government Notification being 5140J dated 20.07.2009 for implementation of the Recommendations of Shetty Commission.
- V. For that Seal Bailiffs are not entitled to Promotion in the Post of GroupD as per the Recommendation of the Shetty Commission since they are
  not at par with the Process Servers in terms of Government
  Notification being 5140J dated 20.07.2009 and on that ground alone the
  impugned Order No. 230 dated 11.08.2015 and Order No. 29 dated
  02.02.2012 is liable to be set aside by this Hon'ble Court.
- VI. For that the concerned Authorities are under the obligation / liability to fill up the Promotional Posts in the L.D.C. Cadre i.e. 25% of all the vacant L.D.C. Posts @ 1:2 i.e. 1(one) from Process Server and (2) from existing Group-D Employees w.e.f. 01.04.2013 in terms of Government Notification 5140J dated 20.07.2009 and as such allow the Petitioner to come under the Zone of consideration for such Promotion as per the Gradation List as on 01.01.2015.
- VII. For that the Respondents have acted in capricious and colourable exercise of Authority vested upon them.

- X. For that the acts and activities of the Respondents complained of are all violative of the Rights guaranteed under Article 14, 16, 19(1)(g), 21 and 300A of the Constitution of India.
- 22. That the instant Petition is made bonafide in the Interest of Justice, Equity and Fair Play.





along with the Group-'D' employees to the extent of 25% in the L.D.C.

Cadre in the ratio of 1:2 (PS- and Gr. 'D'-2) w.e.f. 1.4.2003 and onwards
admissible in terms of G.O. No. 5140-J-dt. 20.07,2009.

. Sir,

I, the qualified Gr. 'D' employee of the Judgeship of Bankura, have the honour to state that for your honour's kind appraisal to the fact that of non-implementation of the recommendation of the Shetty Commission w.e.f. 1.4.03 as regards of promotion to the post of L.D.C. Cadre in the ratio of 1:2 (PS-1 and G. 'D'-2) amongst the senior most and confirmed qualified Gr. 'D' employees and Process-Servers as caused from your end and as a result we have been deprived from getting such promotion.

In this regards I have applied to the earlier District Judge Bankura vide dated 6.8.15 but consequently get no response from his honour's end.

After one and half months I appealed to the Secretary to the Govt. of West Bengal Judicial Deptt., Writers' Building, Kolkata through proper channel vide District Judge Office Memo No. 1644/XIIIO-2 dt. 29.9.2015 as a result Judicial Deptt. passed an order vide his memo no. 616-JD/X/16M-20/15 dt. 26.11.15 to the District Judge Bankura and request to follow the method of promotion as laid down at para 3(c) of the Judicial Deptt. order No. 5140-1 dated 20.7.05 with effect from 1.4.03.

Thereafter I further request to D.J. Bankura after passing the order of the Judicial Secretary Order No. 616-JD/X/16M-20/15 dt. 26.11.15 I request him vide dated 18.12.2015 to implemented the same but no action has been taken till date.

So the method of promotion may kindly be made w.e.f. 1.4.2003 strictly as per direction of the honourable Supreme Court of India which reflects in Judicial Deptt, memo no. 5140-J dt. 20.07.2009.

Therefore I am sorry to say that inspite of Govt. Order we are deprived from getting promotion since effective date.

is pur report of the Review Committee submitted by the Addition al District Judge, lat court, Bankura and the Additional District Judge, 2nd court, Bankura wherein they recommended for issuance of appropriate promotional order to the Post of Balliff in the Judgeship of Bankura from amongst the Cadres of Process Servers and the incumwents named 1)Sk.Naziruddin , 2) Shri Biswanath Das and 3)Shri Sudha mov Chowdhury and other process Servers , if any, having requisite qualification of at least School Final / M.P.Passed, if they are not otherwise barred and subject to attendance/integrity/performance efficiency/health by wirtue of recommendation of the Shetty Commission in terms of Notification No.5140-J and No.5141-J both dated 20/07/2009 issued by the Judicial Department , Govt.of West Bengal with concurrence of the Finance Department (Audit) West Bengal under their U-O No.1561 Gr.P. (service) dt.1.6.2009 in implementation of service condition of the Process Servers of this Judgeship creating / constituting the 2 (two) Cadres namely 1)Process Server/ Summons Baliff and 2) Baliff / Seal Baliff with effect from 1.4. US the order is made as follows :-

Perused and considered the report as well as the Notification of the Govt. of West Bengal , Judicial Department.

In view of the G.O.NO. 5140-J dt.20/7/2009 read with Judgement in Civil Rule No.5139 (W) of 1981 to the consisting Cadres of Process Servers who are required to obtain the Qualification of Passed in School Final or aquivalent Examination and their Pay Scale of 19.3350 - 6325/-(Soale No.6) under W.B.S.Ropa Rules, 1998 has been recommended. The said Cadre be redesignated as Seal Baliff and the Cadre of Process Server be assigned lesser Pay Scale of Rs.3150 -5650/-(Scale No.5).

After careful consideration of all aspects and in view of reports 1) Sk. Naziruddin , 2) Shri Biswanath Das and 3) Shri Sudhamoy Chowdhary having requisite qualification of school Final , are now re-designated as Seal Balliff with the Scale of Pay of Rs.3350 -6350/-(Scale No.6) and other Process Servers of this Judgeship do not come under the purview of the said Notification for implementation of the recommendation of the Shatty Commission.

As per provision of G.O.No. 5141-J dt.20/7/2009 and recommendation of the Review Committee in implementing the recommendation of the Shetty Commission and Seal Baliffs and all the Process Servers attached to the Judgeship of Bankura are entitled to draw fixed Travelling Allowance (F.T.A.)of not less than Rs. 200/-(Rupees two hundred) only per month with effect from 1.4.2003.

In view of the above, the Process Servers who have already retired and the Legal heirs / Nominees of the deceased are also allowed to get their entitlement of F.T.A. for the period.while they were posted in the said post.

## MODE OF RECRUITMENT

50% of the Cadre of Process-Server will be filled up by direct recruitment and 50% by promotion from the Peons/Orderlies having a minimum qualification Standard / merit / integrity/ attendance / performance / efficiency/ health.

The post of Seal Baliff / Baliff will be entirely filled up by promotion from the process Servers having passed requisite by promotion of school Final and marit

Process -Servers alongwith other dategories of Group-D employees having requisite qualification shall be considered for promotion to the extent of 25% in L.D.C. Cadre in the ratio of 1:2 (Process Server -1 and Group-D employee - 2 ).

This order is provisional and issued in the interest of Public service . The undersigned reserved theright of correction or error , if any , if it is found in future.

In case of overdrawal by any of the incumbent, the excess amount drawn by virtue of the order will be recovered forthwith.

Inform the respective heads of offices to do the needful for taking necessary notes in the Service Books of the Seal Baliff concerned and also for payment of F.T.A. to the existing Process Servers and Seal Baliffs and also to the Process Servers who have retired / decessed Govt. employee who have died in harness, from

To the extent of 25% of the resultant ten vacancies in the L.D.C. Cadre mentioned above. two employees i.e. one Process Server against first four vacancies and one Group-D employee employees holding requisite qualification. against next four vacancies are entitled for appointment on promotion to the post of L.D. Cadre. against next rout vacancies are entitled to: appointment on promotion to the post of End. Cauto. Two vacancies occurred due to promotion of Sri Arnab Palit and Smt. Hela Shit should be kept

The present two vacancies required to be filled up, fall at the 20th and 21st point of 50 pending for adjustment in the future occasion of promotion. point roster set out in schedule-II of the West Bengal Scheduled Castes and Scheduled Tribes.

Suspension and break in service are, no doubt, serious stigmas in service life of a government employee for which Sri Chatterjee is considered not fit for promotion to the post of

Now, Sri Kartick Chandra Nayek comes up for consideration. Sri Nayek holds 2nd L.D. Clerk. position in the zone of consideration. No adverse report appears in his service book and as such Sri Nayek is considéred fit for appointment on promotion to the post of L.D.Cierk against 21st

Accordingly Sri Sudhamoy Chowdhury, Process-Server, District Judge's Court, Bankura point of 50 point roster. and Sri Kartick Chandra Nayek, Office peon of the Addl. District Judge's Court, Bishnupur are appointed on promotion to the post of L.D.Clerk w.e.f. 19.08.2015 in Pay band-2, Rs. 5400-25200/- plus Grade pay Rs. 2600/- with ususal allowances.

The reserved vacancy in 21st point shall be carried forward till the next reserved vacancy occurs in 50 point roster.

Sri Chowdhury and Sri Nayek shall remain attached as L.D. Clerks in their presence offices until further order.
